CONTEST DURATION

1. From February 8, 2022 at 12:01 a.m. (ET) to May 2nd, 2022 at 11:59 p.m. (ET). The contest is being held by Sobeys Capital Inc.

HOW TO ENTER

- 2. There are three ways to enter the contest.
 - 2.1. Enter the contest by making a purchase in any of the 10 participating Rachelle-Béry between February 8, 2022 and May 2nd, 2022 and answering to the survey online. The web link to the survey will be printed on cash receipts. You will have until May 2nd, 2022 at 11:59 p.m. (ET) to register your participation online.

OR

2.2. Between February 14, 2022 and April 21st, 2022, we will send invitations by email to randomly selected AIR MILES® members who will be eligible to enter the Contest by completing the online survey.

The web link to participate in the survey* will be included in the communication sent to AIR MILES® Collectors.

* The web link is valid only for ten (10) days. After this time, you will not be able to respond to the survey and therefore to participate in the contest.

letter your name and phone number and the address of the grocery store you visited. We will need to receive your letter no later than April 11, 2022 at 11:59 p.m.

We will accept one (1) opinion letter per envelope, per person and per address for the duration of the contest.

THE CONTEST IS FOR WHOM

3. To all residents of Quebec aged 18 or over. Employees of Sobeys Capital Inc. are not eligible to enter the contest.
